APPLICATION FOR OBTAINING CERTIFICATE OF RECOGNITION FROM THE ACADEMIC SESSION 2024-25 TO 2028-29 (5 YEARS) BY PRIVATELY MANAGED ELEMENTARY SCHOOLS OF ODISHA IN ACCORDANCE WITH THE RIGHT OF CHILDREN TO FREE AND COMPULSORY EDUCATION ACT. 2009 AND ODISHA RIGHT OF CHILDREN TO FREE AND COMPULSORY EDUCATION RULES, 2010 OR APPLICATION FOR SCHOOL OPENING OR

NO OBJECTION CERTIFICATE FOR PRIVATELY MANAGEMENT SECONDARY SCHOOLS

STEPS TO APPLY (Please read the guidelines below before filling up the form)

- 1. First Step: Please create a new account to start filling your application
 - a. Click on 'Create account' link on landing page.
 - b. An email verification link will be sent to your email ID. Click on the link to verify email ID which will be valid for the next 24 hours only.
 - c. Then login to the portal.
- 2. Second Step: Login into the portal with your created credentials
- 3. Third Step: Click on the required link as per application needed to be filled (either School opening form or Certificate of recognition or No objection certificate). Please note that for opening permission, UDISE is not needed but for other two, registration to be done with school UDISE code only
- 4. Fourth Step: Form will open. Start filling the form. All "*" marked fields are mandatory to be filled. All other fields are optional.
- 5. Fifth Step: You may save details once page is filled, by clicking on 'Save' button at the end of the page
- 6. Sixth Step: Once complete form is filled, please click on final 'Submit' button on last page to submit the form. Once you submit the form, you will be able to edit it only till next 48 hours (in case of COR and SO) and 5 days for NOC. After which it would be locked for any further editing.
